A meeting of the Board of Directors of Cameron County Drainage District No. 3 convened on March 10, 2025, at 2:00 p.m. at the office of the District, pursuant to notice duly given as required by law. Present were Ronaldo Garcia, and Jason Shafer, Director; Craig M. Harmon, General Manager; Jack Brown, Engineer; Freddie Ortega, Maintenance Superintendent; and B. R. Dossett, Attorney. President Garcia called the meeting to order and presided.

- 1. Minutes. The minutes for February 10, 2025, meeting was presented and reviewed. A motion was made and seconded that the Minutes of February 10, 2025, meeting be approved. Following a discussion, the motion unanimously carried.
- 2. Public Comment Period. No one appeared. No written comments were received.
- 3. Subdivision Approvals.
  - 3.1. Final Approval.
    - 3.1.1. Country Woods Estates Subdivision, being a 13.24-acre tract out of Block 31, SBL&WCo. Subdivision. Owner Rogelio Salazar, plat preparer JNB Engineering. The plat was presented and reviewed. The motion was made and seconded that the plat of Country Woods Estates Subdivision receive preliminary and final approval, the motion unanimously carried.
    - 3.1.2. 24-FM 510 Subdivision, being a 70-acre tract out of Block 91, Block 92, and Block 81, San Benito Irrigated Co. Subdivision. Owner Tiny Propellers Investments, plat preparer AGH Engineering. The plat was presented and reviewed. The motion was made and seconded that the plat of 24-FM 510 Subdivision receive preliminary and final approval, the motion unanimously carried.
- 4. Annexation and Donation of Drains.
  - 4.1. Annexation.
    - 4.1.1. Request of Yountville Holdings, LLC, Owner, that District Annex 3,060.089 out of Share 22, Espiritu Santo Grant. The Petition for Annexation is with the petitioner for legal review (as of January 2024). No change in status.
  - 4.2. Donations.
    - 4.2.1. Drain C-Right/Drain C-Left/Lateral V, Block 148, San Benito Land & Water Company Subdivision—Donation of Lateral North of Haine Drive and fix boundary of drain. The agreement is with the Attorney still pending.
- 5. Equipment.
  - 5.1. New equipment.
    - 5.1.1 2024 Delco Gooseneck Trailer The trailer (Trailer 1), Vin 5WWGF2525R6034487, was delivered February 11, 2025.
    - 5.1.2 Purchase of new truck for General Manager Request permission to solicit bids and purchase a new truck for General Manager. Following a discussion, the board approved vehicle purchase, the motion unanimously carried.

- 5.2. Disposal of Equipment.
  - 5.2.1 Sale of surplus equipment to CCID #2. The 2015 Ford F350(Unit 60) approved to be sold to Cameron County Irrigation District #2 for \$5,800 was paid for March 4, 2025.

## 6. Projects.

- 6.1. Drains C Left and C Right. No change in status.
- 6.2. East Line Relief Drain Project. Attorney Dossett is finalizing the Right of Way acquisition with subject landowners. Grant funding was applied for through Cameron County for FEMA funding utilizing the Disaster Recovery Reallocation Program.
- 6.3. Drain B-1 and Drain B-2 Interconnect. Engineer Brown is finalizing the plans and Attorney Dossett is working on the Right of Way acquisition. There have been no updates on the acceptance status of the FEMA FMA grant request.
- 6.4. Drain B-2–Upgrade of Pennsylvania Boulevard Road Crossing. FEMA is moving forward with grant approval, no change in status.
- 6.5. Rancho Grande Diversion Project/Drain A Bypass Extension to River Installation of Structure at Outfall. No change in status.
- 6.6. Drain E-Notice of drain ROW in old CPL power plant property. There have been no updates from Attorney Dossett.
- 7. Discuss and take possible action regarding the appointment, employment, and duties of a joint General Manager to succeed the current joint General Manager. The offers presented to employ Carla Marin-Toriz as the joint General Manager and Ubence Escobar as the joint Assistant Manager were accepted, each effective March 24, 2025. The motion was made and seconded that this resolution respecting the General Manager's authority be adopted:

## Whereas

- Pursuant to Texas Water Code § 49.056(a), on March 4, 2025, the Board of Cameron County Drainage District No. 3 employed Carla Marín Toriz as its General Manager, effective March 24, 2025.
- Pursuant to Texas Water Code § 49.056(a), the Board of Cameron County Drainage District No. 3 may delegate to the General Manager full authority to manage and operate the affairs of Cameron County Drainage District No. 3 subject to orders of the Board of Cameron County Drainage District No. 3.
- Pursuant to Texas Water Code § 49.056(b), the Board of Cameron County Drainage District No. 3 may delegate to its General Manager the authority to employ all persons necessary for the proper handling of the business and operations of the District.
- Pursuant to Texas Water Code § 49.054(b) the Board Cameron County Drainage District No.
  3 may by resolution authorize its General Manager to execute a document or documents on behalf of the District.
- Pursuant to Texas Water Code § 49.054(e) the Board Cameron County Drainage District No. 3 may appoint the General Manager as assistant secretary to assist the Secretary of the District's Board of Directors, and to certify as to the authenticity of any record of the District.
- Texas Tax Code § 26.04, requires that the District designate a person to calculate the No-New-Revenue Tax Rates and Voter Approval Rates and to certify the Tax Rate Calculation Worksheets for the District;

Now, therefore, effective March 24, 2025:

- 1. Pursuant to Texas Water Code § 49.056(a), the Board of Cameron County Drainage District No. 3 delegates to Carla Marín Toriz, General Manager, full authority to manage and operate the affairs of Cameron County Drainage District No. 3 subject to orders of the Board of Cameron County Drainage District No. 3.
- 2. Pursuant to Texas Water Code § 49.056(b), the Board of Cameron County Drainage District No. 3 delegates to Carla Marín Toriz, General Manager, the authority to employ all persons necessary for the proper handling of the business and operations of the District, provided:
- 2.1 the Board shall approve the person employed as, and the beginning compensation of, the Assistant General Manager.
- 2.2 the Board shall approve the person employed as, and the beginning compensation of, the Maintenance Superintendent.
- 2.3 the Board shall determine the compensation to be paid all employees of the District, provided, the General Manager shall determine the beginning compensation of new-hires, other than the Assistant General Manager and Maintenance Superintendent, subject to the wage scales and budget adopted by the Board, and provided further, raises shall be governed by the District's Personnel Policy Manual adopted October 16, 2023, or as thereafter amended.
- 3. Pursuant to Texas Water Code § 49.054(b) the Board Cameron County Drainage District No. 3 authorizes Carla Marín Toriz, General Manager, to execute these documents on behalf of the District:
  - 3.1 Grant Applications and all other necessary documents required or needed for securing grants, and for the administration of, and close-out of, grants.
  - 3.2 Plats subdividing land on which there are no District drains or other District drainage facilities.
  - 3.3 Contracts approved by the Board.
  - 3.4 License Agreements and Permits the issuance of which has been approved by the Board.
  - 3.5 The District Registration Form or such other form required by Texas Water Code § 49.054(f).
  - 3.6 All documents necessary for Board approved conveyances of real property, except the deed, which the Board President shall sign.
  - 3.7 All documents necessary for Board approved acquisitions of real property.
  - 3.8 All documents necessary to accept Board approved donations of real property to the District.
  - 3.9 All documents necessary for Board approved acquisitions of rights-of-way.
  - 3.10 All documents necessary for Board approved releases of rights-of-way.
  - 3.11 All documents necessary for Board approved purchases of equipment and vehicles, and Board approved sales of, and trade-ins of, equipment and vehicles, including, but not limited to, title transfer documents and bills of sale.
  - 3.12 Notices of, and Agendas for, Board of Director's meetings.
- 4. Pursuant to Texas Water Code § 49.054(e), the Board Cameron County Drainage District No. 3 appoints Carla Marín Toriz, General Manager, as assistant secretary to assist the Secretary of the District's Board of Directors, and to certify as to the authenticity of any record of the District.
- 5. Pursuant to Texas Tax Code § 26.04, the Board Cameron County Drainage District No. 3

designates its General Manager, presently Carla Marín Toriz, the person to calculate the No-New-Revenue Tax Rates and Voter Approval Rates and to certify the Tax Rate Calculation Worksheets for the District, for tax year 2025 and all years thereafter.

- 8. Discuss and possible action with respect to ERHWSC ROW request near FM 2925. A document was presented to ERHWSC to grant a ROW North of FM 2925 for ERHWSC in return for ERHWSC abandoning an easement for CCDD#3 Eastline Drain project. Awaiting document with signature. After discussion, the motion unanimously carried.

  - 9.1 Drain F Right/F Left in Block 214, SBL&W Co. for Randall Crane road crossing. Pending landowner directions on the locations of the crossings.
